Alusic s.r.l. undertakes to respond within 30 days of receiving this completed form. That period may be extended by two further months where necessary, taking into account the complexity and number of requests. The controller shall inform the data subject of any such extension within one month of receipt of the request, in conjunction with the reasons for the delay.

If the form is not presented personally and therefore direct identification is not possible, it is necessary to attach a copy of the identification document which will be acquired in the records and kept after affixing a notice of cancellation (example: "this document has been acquired by Alusic s.r.l. together with the form for exercising the rights of the interested party presented on....").
